From March - October 2020 day to day operations were overseen by the administrator due to Covid. From October 2020 we employed a General Manager, and from December, we employed a Community Education/ Support Officer and Digital Marketing Project Manager.

For the year ended 31 March 2021

Basis of Preparation

Glaucomoa New Zealand has elected to apply Tier 3 PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and normally has total annual expenses of equal to or less than \$2,000,000. In the year ending 31 March 2021, an unusual bequest income and related expense has increased expenses to over \$2,000,000, but this is not the normal pattern of expenses. The Tier 3 standard allows Glaucome New Zealand to continue to use Tier 3 reporting in this circumstance. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

All amounts are recorded exclusive of GST, except for Debtors and Creditors which are stated inclusive of GST.

Income Tax

Glaucoma New Zealand is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Changes in Accounting Policies

There have been no changes in accounting policies during the financial year (last year - nil)

AUDITOR'S REPORT

Opinion

I have audited the financial statements contained in the Performance Report of Glaucoma New Zealand, a Charitable Trust and registered Charity, for the year ended 31 March 2021. These statements include the Statement of Financial Performance, Statement of Financial Position, Statement of Cash Flows, Statement of Accounting Policies and the Notes.

In my opinion the financial statements provide a true and fair view of the financial activities of the Glaucoma New Zealand for the year ended 31 March 2021 and their financial position at that date according to the reporting requirements for registered charities.

Note that the report also includes non-financial information, on which I express no opinion.

Basis for Opinion

I have taken guidance from New Zealand auditing standards ISA(NZ) in performing this audit in as much as they are applicable to small not-for-profit entities, and also considering the readability of this report for non-accountants.

An audit involves collecting and examining evidence about the numbers and other information presented in the financial statements. The auditor is striving for a very high degree of accuracy and therefore assurance. This also means that the information given in the statements must be complete, with no significant omissions that may mislead the reader of the Statements.

Audit procedures for an entity such as this may involve:
